

# USAGE OF MEIRIK COINS AND VOUCHERS

## TERMS & CONDITIONS

### (‘TERMS & CONDITIONS’)

1. This Usage of Meirik Coins and Vouchers Terms & Conditions regulates the way in which the Meirik Coins can be used and Vouchers utilised.
2. Meirik Limited, a company registered in England and Wales, company number 09928382 with its registered address at 86-90 Paul Street, London, England, EC2A 4NE is the entity that issue Meirik Coins and Vouchers.
3. The following definitions shall apply in these Terms & Conditions (**Terms**):

**Code** means a sequence of characters generated and automatically allocated to a Voucher.

**Commencement Date** means 14<sup>th</sup> September 2021

**Discount** means discount to the cost of Services offered by Meirik Limited of such a value that reflect the number of Meirik Coins allocated to a Voucher.

**Expiry Date** means a day being the last day of the Relevant Period.

**MC Holder** means natural or legal person to whom MC has been issued.

**Meirik Limited** means Meirik Limited, a company registered in England and Wales, company number 09928382 with its registered address at 86-90 Paul Street, London, England, EC2A 4NE.

**Meirik Coin (MC)** means a non-convertible digital coin which may only be used for purchase of Services provided by Meirik Limited whereby each MC shall provide the Discount to the price of Service.

**Relevant Period** means a period of 12 calendar months commencing with the date of issue of a Voucher.

**Sales Broker** means an external organisation that arranges a transaction between Meirik Limited and its clients, including Voucher Holders. A list of Sales Brokers used by Meirik Limited from time to time can be found on this website:

**Services** means any (or all) of professional training courses in English language as offered by Meirik Limited from time to time (as amended by Meirik Limited at its discretion to ensure that it reflects Meirik Limited’s recent portfolios), that full list is available at [www.meirik.com](http://www.meirik.com).

**Service** shall be one of the professional training courses in English language as per the list available at <https://www.meirik.com/upcoming-public-classes>

**Voucher** means a non-convertible digital note issued by Meirik Limited to a Voucher Holder which will specify the number of MC held by the Voucher Holder allocated to the specific Voucher.

**Voucher Holder** means a natural or legal person who obtained a Voucher from Meirik Limited or who has been granted a Voucher by either the natural or legal person who obtained a Voucher from Meirik Limited.

**We, Us** means Meirik Limited.

**You, Your** means the Voucher Holder or the purchaser of the MCs.

4. The instruction on how to utilise your Discount is available at <https://www.meirik.com/docs/vouchers-usage-instruction-ltd.pdf> and will be updated by us from time to time. The instruction should be read in conjunction with these Terms & Conditions.
5. The Discount, defined as per these Terms & Conditions, shall be calculated in the following manner:  
*(number of MC as on the Voucher) / (price of the Service in MC) \* (price for the Service in GBP or PLN).*  
The maximum Discount that can be applied is 100% of the price of the Service.
6. A Voucher may only be applied to one Service and cannot be applied to an aggregate of Services.
7. In order to secure a place in the chosen professional public training offered as Service, you must complete the registration process with our Sales Broker.
8. We do not guarantee that further sessions of the chosen professional public training offered as Service will be provided in the future.
9. Meirik Limited by no means guarantees that the prices for professional training courses offered as Services will remain the same and it reserve a right to change the prices reflected in both, MC and real money at any time. We strongly encourage you to check our websites for the most current prices for our Services.
10. If the cost of the Service exceeds the MC balance on the Voucher (or Vouchers), you must pay any remaining balance in the real money and currency displayed at the time of the purchase.
11. A Voucher may only be used once. If the Voucher has been used, it shall become void and may not be used again.
12. If the cost of the Service is less than the MC balance on the Voucher (or Vouchers), Meirik Limited shall issue a new Voucher to you, to which any unused MC will be allocated. The new Voucher shall include a new Expiry Date where the Relevant Period shall be from the date of the issue of the new Voucher.
13. The Voucher (and any MC allocated to the relevant Voucher) shall automatically expire at 23:59 UTC on the Expiry Date. All MCs which have been allocated to the relevant Voucher shall automatically expire and will no longer be redeemable or transferrable to a new Voucher.
14. The Voucher may not be used retrospectively. If you have not entered the Code and sought to redeem the Voucher at the time of purchase of the Service, MC may not be used to obtain the Discount for Services already purchased, whether such Services have been delivered or not.
15. The MC Holder is responsible for whom and on what terms he shares the Vouchers. Meirik LTD will redeem a Voucher and MC to any person who will present a valid Voucher and MC.
16. Neither Voucher nor MC can be redeemed for cash or returned for a refund. Voucher and MC have no value redeemable for cash and do not constitute legal tender.
17. Vouchers cannot have balances of multiple Vouchers consolidated to a new Voucher or replaced with a new Voucher, unless otherwise agreed by Meirik Limited at its own discretion.
18. We reserve the right to suspend, cancel or amend these Terms & Conditions at any time. If these Terms & Conditions are suspended, cancelled or amended, we will notify the Voucher Holders by email to the email address we hold for the Voucher Holder.
